- I may revoke my authorization at any time, subject to providing notice of 30 days at which time I will submit a cancellation form obtained from the PCC/PWS&D, by contacting my financial institution or by visiting www.cdnpay.ca.
- I have certain recourse rights if any debit does not comply with this agreement. For example, I have the right to receive reimbursement for any debit that is not authorized or is not consistent with this pre-authorized remittance agreement. To obtain more information on my recourse rights, I may contact my financial institution or visit www.cdnpay.ca.
- I waive my right to receive pre-notification of the amount of the pre-authorized remittance and agree that I do not require advance notice of the amount of the pre-authorized remittance before the debit is processed.
- The use, retention and disclosure of personal information collected from this form is done in compliance with privacy legislation, including but not limited to, the Personal Information Protection and Electronic Documents Act (2000, c.5)
