E-Transfers: A Safe and Easy Way to Send Money

The PCC is encouraging the use of e-transfers as a simple, convenient and secure way to send money directly from your congregation's bank account to the PCC bank account. E-transfers are processed quickly and there is no need to issue a cheque or use postage.

Payment by Cheque

If you prefer to pay by cheque, please use the enclosed remittance form to submit payment along with a cheque, payable to The Presbyterian Church in Canada. All payments for *Presbyterians Sharing* and Presbyterian World Service & Development (PWS&D) can go on one cheque. Health and Dental payments, Lending Fund payments and any other loans should be on separate cheques.

Pension and Benefits Payments

The remittance form for Pension and Benefits is a fillable PDF and can be found online at <http://presbyterian.ca/pensionandbenefits>. Once the form is filled in, print and send along with your cheque. Remittances to the Pension Board should be payable to The Pension Board of The Presbyterian Church in Canada and sent to the attention of the Pension Board. This includes: minister's contribution to the Pension Plan, congregation's contributions to the Pension Plan, Group Life Insurance premiums and Congregational Assessment. (Paper remittance forms for Pension and Benefits are no longer available.)
