We are stronger, wiser, and reach further with the healing hands of Christ when we work together.

Reflection

Sometimes we forget that we belong to a church that encircles the globe. It is estimated that there are 2 billion Christians worldwide.

Sometimes we forget that, within this extraordinary church, we are part of a diverse denomination that stretches across Canada. When we devote ourselves to our local congregation, serve as elders, take a casserole to a weary friend, study, pray with a group or help balance the congregation's budget, it can slip our minds that we are also an integral part of The Presbyterian Church in Canada. Our congregation belongs to a presbytery and a synod. We can have a voice in what the national meeting of our church, the General Assembly, discusses and in the decisions it reaches. We do not worship and serve in isolation but with brothers and sisters from Newfoundland to Vancouver Island.

The most immediate relationship the congregation has with the "larger church" is with its presbytery. The presbytery is the next highest court and cares for the congregations and ministers within its bounds. Every congregation is accountable to its presbytery and can be directed by it. It is important for the vitality of both the congregation and the presbytery to foster a healthy relationship.

Some congregations enjoy such a relationship with their presbytery and benefit from care and resources offered to them. Other presbytery-congregation relationships are marked by struggle for a variety of reasons. Every congregation-presbytery relationship can be strengthened.
