Recommendations Taken Together 199/21C

The response to Overture No. 42, 2021 re registry of ministers and congregations re solemnizing same-sex marriage is:

The 2021 General Assembly approved that The Presbyterian Church in Canada holds two parallel definitions of marriage and recognizes that faithful, Holy Spirit filled, Christ centered, God honouring people can understand marriage as a covenant relationship between a man and a woman or as a covenant relationship between two adult persons. At that same General Assembly, Overture No. 42, 2021 was referred to the Assembly Council. The overture asks the church to do three things:

- 1. Establish a national registry of ministers and congregations that are willing to celebrate same-sex weddings and those that are not.
- 2. Request presbyteries to maintain the same kind of registry.
- Prepare guidelines for how a minister who is unwilling to celebrate same-sex weddings would refer a couple to a minister who will conduct same-sex weddings.

The overture, transmitted by the Presbytery of Montreal, notes that it would be pastorally helpful to presbytery clerks to have such a registry so they can provide contact information to same-sex couples seeking to be married in a church. It also maintains that a list of ministers and

congregations not willing to celebrate same-sex weddings may be needed to facilitate dealings with the l'état civil of the Quebec Government, which otherwise might find the refusal by some clergy to marry same-sex couples as arbitrary under Quebec practice. It then speculates that such a registry could eliminate the desire some have to create a separate system of presbyteries based on a choice for or against same-sex marriage.

The working group agrees that it would be pastorally supportive to have a registry of congregations and ministers that will welcome and conduct same-sex weddings for the benefit of same-sex couples looking for a church in which they can be married. Therefore, it supports the creation of a registry.

The working group is not convinced, however, that the registry should include the names of congregations and clergy not willing to conduct same-sex weddings. Ministers have the right to say no to any wedding request and for a variety of reasons. Since the church continues to uphold the definition of marriage as a covenant relationship between a man and a woman, a minister may legitimately be guided by that principle when approached by anyone requesting a wedding ceremony. The decision not to conduct a wedding of a same-sex couple should not be characterized as an arbitrary choice by the minister or congregation but one supported by the theology and polity of the denomination and their individual convictions.

The working group is of the opinion that it would be redundant for both presbyteries and the national office to maintain registries. A publicly accessible registry maintained by the national office should be sufficient. It is not anticipated that a new office or additional staff would be required to oversee this work. Presbyteries could choose to maintain their own registries if they wished.

Whether the creation of such a registry would eliminate the need some feel for a separate system of presbyteries cannot be predicted with certainty.

There are three scenarios which could warrant a listing in the registry as envisioned by the working group.

- Minister and session welcome weddings of two adult persons of the same sex.
 - Both the name of the minister and the congregation could be included in the registry.
- 2. Minister welcomes weddings of two adult persons of the same sex and the session does not.
 - In this case, the minister could conduct weddings of same-sex couples somewhere other than in their own church. The minister's name could be included in the registry and the congregation's name would not. (In this instance, the minister would be required to keep their own marriage register to record weddings they conduct that are not recorded in the congregation's register.)
- 3. Minister does not welcome weddings of two adult persons of the same-sex and the session does.
 - In this case, the session could permit a minister from another congregation to conduct the wedding in the church. Therefore, the session could ask to have the congregation's name included in the registry whenever it is known that an alternative minister is available.

The minister, in this instance, would not have their name recorded in the registry.

The working group believes the submission of information for the directory should be offered on a voluntarily basis by ministers and sessions.

The overture asks for guidelines as to how a minister who is unwilling to celebrate weddings of same-sex couples would refer a couple to a minister who will conduct same-sex weddings. Like any wedding request, this situation would present a pastoral opportunity. The minister can make a connection between the couple and the church, graciously and respectfully explain that they cannot conduct the wedding due to their understanding of marriage and offer to help the couple find a minister who can conduct the service. The national registry might provide the information needed or the minister may know of a nearby colleague who could be approached. When possible, the minister could introduce the couple to the other minister as a further expression of pastoral care.

It was moved by G. Lovelace, duly seconded and

AGREED, that the following recommendations taken together be adopted and referred to the General Assembly:

Recommendation No. 1

that a national registry of ministers and congregations that are willing to celebrate same-sex weddings be created and maintained by the General Assembly Office.

Recommendation No. 2

that the names and contact information of ministers willing to conduct same-sex weddings be recorded in the registry on a voluntary basis.

Recommendation No. 3

that the names and contact information of congregations willing to host same-sex weddings be recorded in the registry on a voluntary basis.

Recommendation No. 4

that the registry be publicly accessible through The Presbyterian Church in Canada website and by other appropriate means of contact with the General Assembly Office.

Recommendation No. 5

that presbyteries be reminded by the General Assembly Office, on an annual basis, to invite the ministers and congregations in their bounds to update their listing in the registry if necessary.

Recommendation No. 6

that the prayer of Overture No. 42, 2021 re registry of ministers and congregations re solemnizing same-sex marriage be granted in the above terms.

Dissent

J. Wilson requested that his dissent be recorded.

I wish to record my dissent to the Same Sex Marriage Register adopted report of Assembly Council in response to Overture No. 42, 2021 for the following reasons.

200/21C

I would like to first commend the authors of the report for a helpful outline that seeks to give good guidance to the denomination as to how to reflect and communicate our parallel definitions of marriage to individuals inquiring about same sex marriage and to any government agencies that may require information. My dissent is not against their sincere efforts to think through the work set before them, but with the interpretation and action of Assembly Council to my request first for a friendly amendment by the authors to include the words "if the minister is in agreement", which was initially agreed to by one of the authors, but then challenged on the floor, made into an amendment and defeated. My dissent is to the understanding of Assembly Council that it is permissible in our theology and practice for the ruling elders to bypass the teaching elder and bring in one who would enact their wishes.

3. Minister does not welcome weddings of two adult persons of the same-sex and the session does.

In this case, the session, {if the minister is in agreement} could permit a minister from another congregation to conduct the wedding in the church. Therefore, the session could ask to have the congregation's name included in the registry whenever it is known that an alternative minister is available. The minister, in this instance, would not have their name recorded in the registry.

The interpretation of Assembly Council goes against hundreds of years of Reformed polity and makes us Congregationalist/Baptist in our understanding of our divisions of authority. The Book of Forms clearly states in 111, "As the executive of presbytery, the minister is responsible for the conduct and content of public worship and for the supply of the pulpit." In our polity the minister is responsible solely to her/his conscience and to her/his presbytery for who they marry, not to the ruling elders alone. This understanding of Assembly Council also allows for the potential for serious division within a charge and undermines the promises that the congregation (including the Ruling Elders) make to the minister during her/his call, especially the promise to "all due respect, encouragement, and allegiance in the Lord".

Secondly, the Book of Forms 247.1 states: All ministers, whether they be on the constituent roll or the appendix to the roll, before agreeing to undertake pastoral services (i.e., baptisms, weddings, funerals) in a congregation other than the one where they are the current incumbent, are required to consult with and receive permission in writing from the session of the local congregation. It is understood that in all cases "session" includes the minister who must be in agreement with the decision to invite another minister into her/his pulpit.

Thirdly, the decision of Assembly Council in this case also undermines the Remits themselves and denies the freedom of conscience and action promised to both sides of the Same Sex Marriage decision. The Assembly Council is therefore in error.

I wish to acknowledge my thanks to the Principal Clerk who approached me following the above decision to convey to me that he and the Deputy Clerk had discussed my concerns following the meeting and understood the point I was making. While I appreciate their counsel that as this is just a scenario mentioned it is not therefore a guarantee of actions to be taken, my fear is that the understanding of Assembly Council would be seen as definitive by others who read the report a certain way.

Should the Clerks of Assembly wish to request that Assembly Council reconsider its understanding of scenario 3, and/or should the Assembly Council move to reconsider the above report prior to Assembly it would be my sincere hope that a helpful clarification could be found.

LEGAL IMPLICATIONS OF REMITS, OVERTURE NO. 4, 2020

Response to Overture 207/21C

S. Kendall presented the report of the Legal Implications of Remits (Overture No. 4, 2020) Working Group.

In the overture, which was received prior to the 2021 General Assembly, the following request was made of the Assembly:

To clear the path to a transparent decision on Remits B and C by making everyone aware of the pertinent information on legal opinions based on the full wording and facts, understand by the legal decisions offered and by the wording of the remits, so that the 2020 General Assembly may be fully competent and confident in its legal understanding before the vote is taken at the 2020 General Assembly.

The Assembly Council considered a response to this overture at its January 2021 meeting but it was rejected in favour of a motion asking instead, that:

The Executive be instructed to retain independent counsel with constitutional expertise to address the matters contained in Remits B and C, 2019 and to report back to the May meeting (January 2020).

This was done, and through the services of Supreme Advocacy LLP, a detailed (52 page) legal opinion was obtained and considered by the Assembly Council, which in turn, made sure that commissioners had the legal opinion (and a four page executive summary) in time for the 2022 General Assembly. The opinion and summary are available at https://assembly.presbyterian.ca/#/search/3001208.

This action fulfilled the request of the overture, that a legal opinion based on the exact wording of the remits be made available to commissioners in advance of making a decision on the remits at the General Assembly.

that Overture No. 4, 2020 be granted through the action of obtaining and publishing a legal opinion based on the wording of the remits in advance of decisions on Remits B and C, 2019.

The Assembly Council was asked to respond to two referrals from the 2021 General Assembly that came in the form of recommendations from the Life and Mission Agency.

Recommendation No. LMA-002: That the General Assembly seek to eliminate the use of single-use non-biodegradable plastics and Styrofoam at all their meetings.

Recommendation No. LMA-003: That congregations, presbyteries, synods and committees of the church be encouraged to eliminate the use of single-use non-biodegradable plastics at all their meetings.

Following consulation by the General Assembly Office staff regarding these recommendations, it was confirmed that in recent years, the venues we have used for the General Assembly have been conscientious about not using non-biodegrade plastics and Styrofoam or willing to not use them for our meetings. The General Assembly Office will continue to ensure that this matter is raised and ensure that, wherever possible, such items will not be used.

Similarly, arrangements for the Assembly Council meetings, wherever possible, will make not using such items a high priority.

LIFE AND MISSION AGENCY COMMITTEE 213/21C The convener of the Life and Mission Agency Committee, C. Stephenson, presented its report.

Honouring the Children Fund Terms of Reference 214/21C The terms of reference for Honouring the Children Fund are as follows:

Purpose

In honour of the children who were lost and all people living with the consequences of that legacy, The Presbyterian Church in Canada established the *Honouring the Children: Reconciliation and Residential Schools Fund*. This Fund will support initiatives associated with searches for unmarked burial sites in communities where schools were operated by The Presbyterian Church in Canada.

Programming of Funds

This work begins with listening. We continue to live out the covenants made in the 1994 Confession, be led by the principles articulated by the Truth and Reconciliation Commission of Canada and seek the guidance of Indigenous people and affected communities. All grants will emerge from, and take into account, consultations with affected communities. Other related groups, including churches and the Indigenous-led Centre of Expertise sponsored by Crown-Indigenous Relations, may also be consulted. All work will complement efforts to address systemic racism against Indigenous people, both in the church and Canadian society, and the ongoing healing and reconciliation work being done in the ministries of the National Indigenous Ministry Council. This is not an endowment fund and the Fund is intended to be spent as required.

What can the Fund support?

- Consultations with Indigenous communities needed to ensure this work is carried out in a good way.
- Costs associated with searches of cemeteries and unmarked burial sites on the grounds of, or associated with, The Presbyterian Church in Canada run schools, including actual searches.
- Follow up actions including but not limited to, repatriation of remains, commemoration or memorials, healing and health supports healing from trauma all in accordance with family and community members' wishes.

Disbursal

Funds will be disbursed as requests are received.

Discernment

One person named by each of the National Indigenous Ministries Council, Life and Mission Agency and the Assembly Council with appropriate staff will be responsible for discernment.

Reporting and Administration

The Life and Mission Agency will be responsible for administration of the grants and providing reports to the National Indigenous Ministries Council, the Life and Mission Agency Committee and the General Assembly.

Contributions

The Assembly Council designated an initial \$100,000 and committed to at least \$1,000,000 for this work. Individuals and congregations have been invited to make additional gifts. Funds may be solicited from other groups.

Reporting

A narrative of Fund uses will be prepared for the General Assembly.

Background

In response to the devastating confirmation of unmarked graves on the grounds of former Residential Schools in Canada, The Presbyterian Church in Canada published *A Statement Regarding Residential Schools* on June 15, 2021. The statement included the following commitment:

We have heard The Presbyterian Church in Canada must work to ensure the grounds of the residential schools we ran – and especially Birtle and Cecilia Jeffrey, which we ran the longest – are searched for any unmarked graves. We must also ensure any search is taken in respectful consultation with the Indigenous communities and families impacted; this would include financial support from the church for those searches. We commit to this work.

The Life and Mission Agency Committee and members of the National Indigenous Ministries Council have developed these terms of reference taking into consideration the wishes of Indigenous peoples and affected communities.

Recommendation No. 1

Funding for Harm Done 215/21C

The terms for funding for Harms Done (Rec. RCL-006, A&P 2021, p. 655) are as follows

Establishing Terms

The terms to provide support from The Presbyterian Church in Canada's Emergency Benevolence funds for psychotherapy/counselling for those who have experienced harm done by homophobia, hypocrisy, transphobia and heterosexism in the denomination are established by the Assembly Council.

Available Funds

Up to \$100,000 per year from 2021–2024, to be reviewed annually, be available from the emergent benevolence funds for disbursal. Unless additional designations are made, requests for support thereafter will continue to be considered from the emergent benevolent funds, after annual consultation with the Benevolence Committee.

Eligibility

People who have experienced harm done by homophobia, hypocrisy, transphobia and heterosexism in The Presbyterian Church in Canada are eligible to be considered for financial support.

Use of the Funds

Funds can be used for psychotherapy and counselling related to harm done by experiences of homophobia, hypocrisy, transphobia and heterosexism in The Presbyterian Church in Canada. In 2019, The Presbyterian Church in Canada reaffirmed its statements that homosexual orientation is not a sin and that studies have not revealed any scriptural, scientific or pastoral basis or justification for programs designed to change a person's sexual orientation and therefore acknowledged that any form of conversion or reparative therapy is not an appropriate pastoral response for those who identify as LGBTQI. Therefore, funds will not be available to support any course of therapy or counselling that is designed to change a person's sexual orientation.

Consideration

Requests will be considered and discerned promptly on a case-by-case basis.

Discernment

Discernment will be made by the Principal Clerk of the General Assembly, the General Secretary of the Life and Mission Agency and the Program Coordinator, Sexuality and Inclusion. From time to time, it may be prudent and advisable for any one of these discerners to appoint an appropriate designate.

Confidentiality

All enquiries and any information that the discernment committee receives will be kept strictly confidential.

Administration of the Funds

The Life and Mission Agency will be responsible for the pastoral administration and dispensation of the funds.

Reporting

The Life and Mission Agency will report to the General Assembly and the Benevolence Committee.
