NO. 15 – PRESBYTERY OF CALGARY-MACLEOD

Re: Review of the sick leave policy

- WHEREAS, The Presbyterian Church in Canada in its role as a responsible employer has a Sick Leave Policy that has been in place since 1990 clearly outlining one path that may lead to long term disability, which needs review and revision; and
- WHEREAS, there are medical events that may take longer for recovery that are not eligible for long term disability and that lie outside the scope of the policy as it stands; and
- WHEREAS, the reality of the policy may lead to the severance of the pastoral relationship between the minister and congregation in cases where there is an inability to return to work after six months and no possibility of long term disability benefit. This leaves the minister and family in an extremely vulnerable condition without pay and putting benefits and pensionable service at risk; and
- WHEREAS, the current policy is not clear how to mitigate the probable claw-back of Employment Insurance sick leave benefits a member may encounter in the fourth to seventh month when the congregation is still required to provide a Housing Allowance placing undue stress on an already stressful situation; and
- WHEREAS, members can be at the most vulnerable when they are experiencing medical events or transitions in ministry and require clearer information from the employee policies of the church to navigate these events; and
- WHEREAS, it is the practice of the church to encourage generosity for congregations in their treatment of employees especially in the application of church policies, yet it seems that the current operating policy of the Pension and Benefits Board is to remove benefits that are not required by the law without permission from the General Assembly undermining that example and principle of generosity,
- THEREFORE, The Presbytery of Calgary-Macleod humbly overtures the Venerable, the General Assembly to 1) direct the Pension and Benefits Board to review and revise the current Sick Leave Policy to include a pathway in addition to long term disability, such a revision should include recommendations on how to protect the stipend and benefits of the member in cooperation with the Canada Revenue Agency, and 2) to remind the Pension and Benefits Board that all changes to policies in relation to any benefit currently offered must be approved by the General Assembly, or to do otherwise as the General Assembly, in its wisdom, may deem best.
