## SECOND SEDERUNT

## WORSHIP

The Assembly was led in worship by the Rev. Paul Kang, who preached the sermon and was assisted by pianist and liturgist Ferenc (Frank) Szatmari and guitarist Reuben St. Louis.

#### ASSEMBLY CONSTITUTED

At the Athletic and Recreation Centre of Wilfrid Laurier University, Waterloo, Ontario, on Monday, June 3, 2024 at 9:30 a.m., the Assembly met pursuant to adjournment. The Moderator constituted the Assembly with prayer.

#### TERRITORIAL ACKNOWLEDGEMENT

The Moderator read the following Territorial Acknowledgement.

Those of us gathered here have come from many places that are the traditional lands and territories of many different First peoples. But today we acknowledge that the land we are gathered on here for our General Assembly is the traditional territory of the Neutral, Anishnaabeg (ah-nish-naw-beg) and Haudenosaunee (hoe-de-no-show-nee) nations; that they have cared for it and lived in relationship with it and with the plants, animals and waters around and within the land for thousands of years.

We acknowledge with respect the importance and sacredness of this land to the Neutral, Anishnaabe and Haudenosaunee nations; the significance the land holds within cultural and spiritual practices, and the rootedness of Neutral, Anishnaabe and Haudenosaunee families and communities within the land we are gathered on today.

We come from a tradition steeped in an understanding of holy ground but we know that we are still learning how to walk humbly on that ground. Part of our learning to walk humbly is learning the history of the land and the history of the peoples first in relationship with it; who first cared for this land and what that relationship means to the people who were the first caretakers and who continue in that role today; what treaties have been made and how they are being lived out.

The Neutral, Anishnaabe and Haudenosaunee people have cared for and protected this land and these waters for millennia and they still care for and remain in relationship with the land today.

Some of that care and protection and living in relationship with the land was treaty-making; this land is part of the Dish with One Spoon Treaty between the Haudenosaunee and Anishnaabeg peoples, which is an agreement about how land and resources are to be shared, and how people are to be in relationship with one another. We acknowledge the ongoing importance that Treaty continues to hold for all people on these lands.

The land we are gathered on today is also part of the 1784 Haldimand Treaty, signed by the British and their allies, the Six Nations, after the American Revolution. That treaty was also to be an agreement about how to be in relationship but we acknowledge that it has not been followed; the Six Nations of the Grand River now reside on less than five percent of the land covered by the original treaty.

Lastly, and only first having acknowledged the Neutral, Anishnaabeg and Haudenosaunee nations, the deep significance and relationship the land hold for them, and the treaties that cover this place, we acknowledge our own identity and relationship with the land and the First Peoples as The Presbyterian Church in Canada, a church that participated in colonization. We acknowledge the harm we have done as well as the commitments we have made to redress that harm. In doing so, we lift up the ongoing work needed for healing and reconciliation.
