#### Amendment

E. Nemeth moved, duly seconded, that the word "Hungarian" before the word "diaspora" be deleted; the words, "with power to issue" be inserted after the word "Council"; the words "and the Canadian Hungarian Presbyterian Churches Consultation Committee" be inserted after the words "Clerks of Assembly"; and the sentence "That the Canadian Hungarian Presbyterian Churches Consultation Committee be recognized as an authentic and true representation of the Hungarian ethnic congregations and as an important constituency in its own right in The Presbyterian Church in Canada and in close cooperation with the Assembly Council and the Clerks of Assembly to form a Canada wide Diaspora Mission Presbytery which will have an oversight and wide ranging power to deal with the diaspora missionary outreach and be recognized as equal partners with Presbyteries across the nation." be added as a new paragraph.

## MACLEAN ESTATE COMMITTEE

The Assembly called for the report of the Maclean Estate Committee which, as printed on p. XXX, was presented by E.A. Naylor, convener. He was accompanied by the Executive Director, the Rev. Kristine O'Brien.

E.A. Naylor gave thanks for the Crieff employees and others who have supported the work of Crieff Hills Community. It was reported that the community is celebrating 50 years of ministry.

A video highlighting the facilities and opportunities offered by the retreat centre was viewed by the Assembly.

#### INTERNATIONAL AFFAIRS COMMITTEE

The Assembly called for the report of the International Affairs Committee which, as printed on p. XXX, was presented by C. Ireland, convener.

Recommendation IAC-001 (p. XXX) was moved by M. Bereczki-Farkas, duly seconded. Adopted.

Recommendation IAC-002 (p. XXX) was moved by M. Bereczki-Farkas, duly seconded. Adopted.

#### Dissent

B.D. Bertrand asked that his dissent regarding Recommendation IAC-003 be recorded in the minutes, with reasons.

The report acknowledges the complexity of the conflict between Palestine and Israel but then vilifies only one participant – Israel. Hamas gets condemned for the October 7, 2023 attacks but not for its ongoing role and participation in the larger conflict. The problem is that without explicitly addressing the moral culpability of Hamas, we neglect to address one of the root issues in this conflict – anti-Semitism. Hamas is explicitly and unabashedly anti-Semitic. They exist to eradicate Jews. October 7th was not just a violent attack but an attack on people because they were Jews. It was a hate crime. To not condemn Hamas for anti-Semitism, all the while supporting Palestine and vilifying Israel, is, at best, to remain silent about a mortal sin fundamentally at work in the conflict and, at worst, to tacitly approve of anti-Semitism.

This has implications for our life and witness here in Canada. Anti-Semitism is on the rise. Pro-Palestinian protestors on campus chant "From the River to the Sea", calling for the annihilation of the Jews. Synagogues have engaged in extra security because of legitimate violent threats. Rabbis and Jewish leaders have been intimidated. Jewish children have been harassed. Of course, this is not the fault of the women and children of Palestine, the subject of the motion. But, when we only vilify Israel, as justified as moral condemnation is, we send a message to our Jewish friends and colleagues that we have nothing to say about the anti-Semitism they face in Israel and in Canada.

## Amendment

P.G. Bush moved, duly seconded that the sentence, "And that this be done in humility, confessing the history of anti-Semitism within The Presbyterian Church in Canada and the church's own actions of colonialism, using the church's tools of prayer and spiritual reflection to participate in God's vision for a just peace in the Middle East." be added to the recommendation after the word "region". Adopted.

## Recommendation IAC-007 as amended, was adopted, as follows.

That congregations, presbyteries and synods be encouraged to find concrete ways to live out this commitment and use resources created by the church, KAIROS, Sabeel and Project Ploughshares on justice in the region. And that this be done in humility, confessing the history of anti-Semitism within The Presbyterian Church in Canada and the church's own actions of colonialism, using the church's tools of prayer and spiritual reflection to participate in God's vision for a just peace in the Middle East.

#### Report as a Whole

Bereczki-Farkas, moved, duly seconded, that the report as a whole be adopted. Adopted.

## ECUMENICAL AND INTERFAITH RELATIONS COMMITTEE

The Assembly called for the report of the Ecumenical and Interfaith Relations Committee which, as printed on p. XXX, was presented by L. Campbell, convener.

This report contained no recommendations.

L. Campbell drew attention to some of the highlights in this report. She announced that Amanda Currie has been named the next president of the Canadian Council of Churches.
