#### NARRATIVES THAT SHAPE US

The Rev. Jean Morris, the convener of the Assembly Council working group created to consider Narratives of Hope and Possibility for The Presbyterian Church in Canada, explained that the working group is eager to engage this Assembly in a conversation about narratives. Commissioners were encouraged to have conversations, in table groups, that focused on positive stories that would point toward greater potential for the future of the denomination. They were invited to be guided by the following questions and to attach biblical or theological themes and insights to their narratives.

- 1. Theologically, what are the narratives that shape your identity and your faith community's identity?
- 2. In what ways do those narratives give you hope?
- 3. Considering the conversations that you've had, is there a topic, theme or idea that has emerged? Is there something you would like to highlight? Or is there something that didn't come up but you feel it has to be named for the sake of hope and possibility for The Presbyterian Church in Canada?
