## WORSHIP

The Assembly was led in worship by the Rev. Peter J. Rombeek, who preached the sermon, and was assisted by liturgist Kristine O'Brien and musician Hugh Donnelly.

#### ASSEMBLY CONSTITUTED

At the Athletic Complex of Wilfrid Laurier University, Waterloo, Ontario, on Thursday, June 6, 2024, at 9:40 a.m., the Assembly met pursuant to adjournment. The Moderator constituted the Assembly with prayer.

## 80TH ANNIVERSARY OF D-DAY

Captain K.L. Barlow, a Chaplain with the Canadian Armed Forces, was invited forward by the Moderator to announce that this day marked the 80th anniversary of the D-Day landings on the beaches of Normandy, France, and led the Assembly in a moment of silence.

#### **GRATITUDE**

The Moderator expressed gratitude to commissioners, resource people, General Assembly Office staff, tech support personnel, and worship leaders for their contributions to the Assembly. She also thanked her chaplain, the Rev. Kathy Fraser, for her prayers and assistance.

#### YOUNG ADULT REPRESENTATIVES

The Moderator invited the Young Adult Representatives to address the Assembly. One by one, they spoke passionately and eloquently as they reflected on their experience at this Assembly and their hopes for the future of The Presbyterian Church in Canada.

#### COMMITTEE TO EXAMINE RECORDS

## **Recommendation CER-001**

P.H. Wu moved, duly seconded, that the minutes of the Synod of the Atlantic Provinces, the Synod of Manitoba and Northwestern Ontario, the Synod of British Columbia, the Assembly Council and the 2023 Acts and Proceedings be attested as neatly and correctly kept. Adopted.

### **Recommendation CER-002**

P.H. Wu moved, duly seconded, that the minutes of be the Synod of Central, Northeastern Ontario and Bermuda, the Synod of Southwestern Ontario, the Synod of Saskatchewan, and the Synod of Alberta and the Northwest be attested as with notes. Adopted.

P.H. Wu moved, duly seconded, that the report as a whole be adopted. Adopted.

## **COMMITTEE ON REMITS**

The Assembly called for the report of the Committee on Remits which, as printed on p. XXX, was presented by W.C. Stewart, convener.

## **Recommendation REM-001**

W.C. Stewart moved, duly seconded, that Remit A, 2023 re Book of Forms 288.1 re appointment of the General Assembly's Committee to Nominate Standing Committees be approved and that this become the law of the church and that the Book of Forms be amended accordingly. Adopted.

#### **Dissent**

P.H. Wu asked that his dissent regarding Recommendation REM-001 be recorded in the minutes, with reasons.

Prior to sending this remit down under the Barrier Act for a 'yes' or 'no' vote, there was no opportunity for 'study and report' on the part of presbyteries and/or synods. Some informal conversation may have taken place but that does not

substitute a formal request for 'study and report'. Since this change constitutes a substantial change in the role of synods, it is regrettable that they are not properly consulted. Synods are well placed to know the personnel within their bounds who have the gifts, skills and experience suited to service on not only the Committee to Nominate but also on the national committees and boards of the General Assembly. The previous practice that each synod nominates one member to serve on the Committee to Nominate ensures that there is broad grassroots input in selecting qualified members on that committee. The new wording of Book of Forms 288.1 has shifted the power to name candidates from the synods to the Assembly Council. In pursuit of the 'ethnic and cultural' diversity, it is unfortunate the geographical diversity of the regions and the diversity of a balanced clergy/lay representation are sacrificed. While the goal of a better 'ethnic and cultural' representation is laudable, the mechanism envisioned by Book of Forms 288.1 is clunky at best. In my humble opinion, the vision that truly is worth embracing is the dream of Marin Luther King Jr. that his four little children will one day "live in a nation where they will not be judged by the colour of their skin but by the content of their character".

#### **Recommendation REM-002**

W.C. Stewart moved, duly seconded, that Remit B, 2023 re Book of Forms 176.1.6 and 176.1.7 re presbytery constituent roll be approved and that this become the law of the church and that the Book of Forms be amended accordingly. Adopted.
